Fooled by the opposing party's theatrics, the court's evaluator's recommendation was for the opposing party to have primary custody. After a very effective cross examination of the custody evaluator, the judge awarded primary custody to his client.
- Represented the grandparents of two children whose parents were not in any condition to give the children what they deserved a stable home and a healthy environment. When the children's mother disappeared with the children, Adam was able to track her down and eventually get an Emergency Order, which awarded his clients temporary sole legal and physical custody of the children. After a four day custody trial, the grandparents were eventually awarded primary physical custody of the children.
