Adopting this process has allowed the clients to ensure the early acceptance of tender while obtaining reimbursement for their legal expenses. Utilizing private arbitration has allowed Lars to recover millions of dollars of legal fees for these clients. His clients have also been able to utilize the success in obtaining tender acceptances by their subcontractors to reconfigure their insurance needs thereby achieving millions of dollars in additional savings.
